The 8th Annual Capital Cup was held on September 15th – 18th, 2023 with a new title sponsor of L5 Investments (past sponsor Villara Building Systems).

This year's 32 participating golfers raised \$1,847,396.00! In the past, this is the largest charity event in Sacramento. This event raises more charity dollars than the Big Day of Giving each May.

Each participants pays a \$2,500.00 fee to participate in the fundraiser. This fee covers all event administrative and operating expenses allowing 100% of raised dollars to go directly toward each player's charity.

I am sure it's fun for the 32 players to play 3 competitive round of golf in 3 days, but the real fun is watching each charity receive their WINNING check (see photo attached)!

### JUNIOR GOLF DEVELOPMENT GRANTS PROGRAM

SURPASSES \$330,000 IN JUNIOR GOLFER SUPPORT!

The Morton Golf Foundation (MGF) is proud to state that over \$330,000.00 has been awarded to support Junior Golfers over the 9 years of Junior Golf Development Grants!

MGF Junior Grants help Junior Girls and Boys attain and surpass their education and golf goals.

By supporting junior tournaments, lessons and equipment needs, MGF helps junior golfers use the game of golf to win college scholarships. Over the Junior Golf Development Grant history over 30 Junior Golfers have received golf related college scholarships.

These scholarships are a gateway to building strong young citizens who will succeed in any endeavor they choose.

#### APPLYING FOR A MORTON GOLF FOUNDATION JUNIOR GOLF DEVELOPMENT GRANT IS EASY:

- 1. If you live within a 50 mile radius of Haggin Oaks Golf Complex and are a junior golfer between the ages of 12 (by end of application period) and 18 (not enrolled in college) just go to MGF website at www.mortongolffoundation.org. Put your cursor on how we help, click on youth opportunities, scroll down to MGF Junior Golf Development Grant requirements and application, scroll down to the application. Fill out the application and hit submit.
- 2. Once application is received the MGF Interview Committee will schedule an interview for each applicant.
- 3. The Interview: Prior to the interview each applicant will receive several worksheets to complete. During the interview both parents and their junior player will be asked questions. As the interview progresses, using the completed worksheets, a golf plan is created specifically for each junior's needs.
- 4. When all junior applicant's interviews are completed, the MGF Interview Committee determines by individual junior applicant if the applicant receives a grant and the dollar amount of the grant. All applicants are notified of the MGF Interview Committee's decision.

The Morton Golf Foundation is looking forward to awarding more Junior Golf Development Grants in 2024. As junior golfers needs grow, so do our levels of funding!



The California Eagle program is one of the longest standing programs of SAY Golf/First Tee - Greater Sacramento. It dates back to 1985 with a group of 10 special needs athletes. Fast forward to 2023 and now the program has 100+ athletes and runs at both William Land Golf Course and Haggin Oaks Golf Complex. The season itself starts in late Spring and operates until the middle of September. Athletes meet once a week at their appropriate golf course for an hour and a half, each week working on a different skill.

#### Angels for Hearts - "I W Golf" Program 2023 | By Curtis Kaufman

Angels for Hearts is a Sacramento-based nonprofit. Their mission is to bring normalcy to pediatric heart patients ages newborn to 18, both in and out of the hospital. The nonprofit reminds heart kids that first and foremost they are kids before being heart patients. Angels for Hearts is truly one-of-a-kind, filling the 'Wishes, Wants &/or Needs' of pediatric heart families that have never been met before.

For those who love sports, it can become a wonderful passion. A way for families and friends to spend time together. At an event held by Angels for Hearts in August 2013, they found out that golf was the sport that was highly suggested by pediatric cardiologist for their patients to play. Why golf? According to Dr. John Chin "A round of golf is great for physical fitness—it is not overly strenuous, yet exercises muscle groups of the arms, legs, back and abdomen. Walking the course and a full, 18-hole round of golf involves a walk of around 5-7 miles or more. The less energetic players can choose to ride in a golf cart and play 9-holes or just putt and chip, still expending a significant amount of energy."

Hearing this by January 2014, Angels for Hearts developed a first-of-its-kind "I ♥ Golf" program giving heart kids and their siblings the opportunity to learn and grow the game of golf. For many children with a Congenital Heart Defect or CHD, "I ♥ Golf" is the first sport they have ever played. "I ♥ Golf" is a series of golf clinics, held at Haggin Oaks, hosted in partnership and affiliation with the Morton Golf Foundation and the Northern California Institute of Golf.

Angels for Hearts believes that heart families are first and foremost families before being heart patients. So, it was important to include the siblings. Golf is a great sport for the entire family; 2023 was their 10th season. Golf is great for kids because it is not just a sport it also teaches life lessons. Learning life lessons is important, but our heart families also have a chance to share live experiences with others who have heart kids and Heart Angels.

What are Heart Angel Families? Heart angel families are families that have lost a child to a cardiac issue. Many of our heart families are both heart families with a child with CHD and heart angel family having lost a child to CHD. It is a difficult topic for most families to share. Children born after the loss of a CHD child are often called "rainbow babies." After the storm, a rainbow appears, this is where the term comes from. Below is a quote from a Heart Angel Family.

Colin and Brittani Supenia, Heart Angel Parents to Wyatt, and big sister Hadley (heart healthy sibling) (Klamath Falls, Oregon)

"Once a heart family always a heart family".

Our family became an "Angels for Hearts" family under devastating circumstances.

Our sweet boy, Wyatt, was diagnosed with a rare genetic heart disorder. Angels for Hearts was so helpful from the moment we were connected. Unfortunately, Wyatt passed away and they have continued to be in our lives. Angels for hearts not only helped our immediate family but our entire family. I grew up in Sacramento before, marrying and having a family. My twin sister, Brooke as well as extended family still live in Sacramento. Our niece, Payton, was able to join the "I ♥ Golf" program. It has helped us connect with other heart parents, giving us an outlet to share our struggles and situations with others who have been in the same situation. Payton has participated "I ♥ Golf" program and benefited from the GolferShips awarded to all participants to continue lessons. We have loved watching her develop her confidence and golf skills."

Heart kids and their families do not take life for granted; they live. They make their own normal, in a not-so-normal world. That is why it is so important that Angels for Hearts provides a sense of normalcy for the heart families.

On behalf of Angels for Hearts, we thank Lead Instructor Alex Cooper for providing our golfers a wonderful learning environment, and the Morton Golf Foundation, Haggin Oaks Golf Complex and the Northern California Institute of Golf for their generous support of "I ♥ Golf."

"I ♥ Golf" is truly blessed to have the long-term relationship with the Morton Golf Foundation. Because of the generosity of donors, volunteers from the National Charity League Granite Bay Chapter we are excited for our 11th season of "I ♥ Golf" in 2024 and continuing to grow the game of golf one heart family at a time.

#### **Greetings**

I hope this finds you well and I know you are looking forward to the second half of the season for the 2023 "Golf Fore Health" program. I wanted to take a quick moment to say Thank You to the people that allowed me to add five years on to my golfing career just by giving me the equipment, the encouragement and the will to participate in a friendly loving environment. As you know or may not know, during the break this summer I relocated to the Midwest to be closer to kids and grandkids. I found a beautiful home in SE Kansas that sits on 10 acres of partially wooded land with a creek running through it. Very peaceful near the town of Chanute, KS in Neosho County.

This message is going to Tom Morton, Jane Siebers, Ken Hurdle and David Windsor. Dave was my first contact for what I found was called Adaptive Golf. Dave was situated in Georgia and has dedicated his career to working with people like me and has a National Patriot Award for working with disabled veterans. We had numerous correspondence on my condition and my location. called one day and asked me if Haggin Oaks was anywhere near my town. I answered that it was actually in my neighborhood! You would never guess how difficult and demanding Jane's job is. Primarily because she is always up and positive and always approachable.
